STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Parks Racecourse
by the South Australian Jockey Club on Saturday, 6 June 2020

RACE 1: FLEURIEU MILK COMPANY HANDICAP - 1950 Metres

RESERVE STREET (L. Neindorf) - inside the 900 metres when crossed by BUDD FOX, shifted out in an attempt to obtain a position outside BUDD FOX and in doing so contacted BOX ON COLLINS for several strides taking this horse a little wider before being obliged to again settle behind BUDD FOX as BOX ON COLLINS maintained its position. From inside the 600 metres was unable to improve its position when racing behind BUDD FOX and inside BOX ON COLLINS and thereafter approaching the 400 metres, shifted to the outside of BOX ON COLLINS to improve and was taken a little wider near the entrance to the straight by BOX ON COLLINS as that horse shifted out. Rider reported his instructions were to attempt to obtain a soft lead in the early stages of the event. He stated that while he was initially able to do so, after being crossed by BUDD FOX near the 900 metres, which improved and crossed to the fence, he elected to shift to the outside of that horse so as not to be trapped inside runners, as he was also instructed that the gelding had a tendency to be weak when racing inside runners. He added that he was unable to shift BOX ON COLLINS and consequently was obliged to maintain his position behind BUDD FOX for some distance and approaching the 500 metres was hoping to gain a run to the inside of BOX ON COLLINS however, was unable to do so, and was obliged to shift to the outside of BOX ON COLLINS near the entrance to the straight to improve his position and was taken a little wider by BOX ON COLLINS which shifted out. He further added the gelding was one paced in the straight. A post-race veterinary examination revealed no visible abnormalities.

BOX ON COLLINS (B. Vorster) - inside the 900 metres was contacted for several strides by RESERVE STREET which shifted out. Approaching the 400 metres shifted out slightly. Raced greenly in the straight. A post-race veterinary examination revealed no visible abnormalities.

BUDD FOX (D. Tourneur) - slow and knuckled at the start losing two to three lengths.

RACE 2: DOMINANT HANDICAP - 1000 Metres

ARROW LANE (S. Fawke) - near the 700 metres was crossed by IRISH MINT, which shifted in to improve its position, was tightened onto WHITE KAPS to its inside inconveniencing that horse, and had to be restrained and shifted out to avoid the heels of IRISH MINT as a consequence.

RACE 2: DOMINANT HANDICAP - 1000 Metres (Cont'd)

IRISH MINT (C. Jones) - near the 700 metres shifted in to improve its position and crossed the running of **ARROW LANE**, which was tightened onto **WHITE KAPS** to its inside inconveniencing that horse, as a consequence **ARROW LANE** had to be restrained and shifted to the outside of **IRISH MINT** to avoid its heels. Rider pleaded guilty to a charge of careless riding under AR131(a) in that she shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Monday, 8 June and to conclude at midnight on Sunday, 14 June 2020: a period of three meetings. In determining penalty, Stewards had regard for the degree of carelessness, the severity of the consequences, C Jones' guilty plea and her good riding record. Laid out in the straight. Rider dropped her whip near the 100 metres.

BE MY STAR (T. Pannell) - near the 700 metres was tightened and inconvenienced when racing inside **WHITE KAPS** as that horse was taken in when tightened. A post-race veterinary examination revealed no visible abnormalities.

STAR OF MONSOON (J. Holder) - contacted at the start.

WHITE KAPS (K. Crowther) - contacted at the start by **MUSICAL QUERY** and as a consequence became unbalanced for a number of strides. Near the 700 metres was inconvenienced by **ARROW LANE**, which was tightened and taken in by **IRISH MINT** as that horse crossed to improve its position. Held up for clear running from near the entrance to the straight until approaching the 200 metres.

MUSICAL QUERY (T. Voorham) - shifted out shortly after the start, contacted **STAR OF MOONSOON** and as a consequence, knuckled and shifted in contacting the hindquarters of **WHITE KAPS** and as a consequence became unbalanced for a number of strides. Thereafter over-raced in the early stages of the event.

RACE 3: FURPHY THREE-YEAR-OLD MAIDEN PLATE - 1000 Metres

PEARL DRAGON (J. Holder) - began awkwardly, shifted in and contacted **INCITER**, which was tightened onto **FLIRTING**. Laid in severely in the straight. A post-race veterinary examination revealed no visible abnormalities.

ZEBONET (P. Gatt) - rider reported the gelding hung in throughout the event.

FLIRTING (L. Neindorf) - Trainer Mr A. Freedman advised Stewards of a change in tactics, that being that he would instruct L Neindorf to not lead in the event but attempt to settle behind the leaders and obtain cover. Began awkwardly and shifted out onto **INCITER** contacting that horse and tightening it onto **PEARL DRAGON**.

LA RAPIDE (T. Pannell) - is a grey filly and not as recorded in race book as a bay or brown filly. A post-race veterinary examination revealed no visible abnormalities.

POLLYANNA (B. Vorster) - a little awkward to begin. A post-race veterinary examination revealed no visible abnormalities.

SHE'S KRUP (D. Tournour) - held up for a short distance rounding the home turn.

ZARAFSHAN (T. Voorham) - inclined to lay out in the straight.

INCITER (S. Logan) - underwent a pre-race veterinary examination as it had not raced since April 2019 and was passed fit to race. Tightened at the start between **PEARL DRAGON** and **FLIRTING**, which both began awkwardly. A post-race veterinary examination revealed no visible abnormalities.

RACE 4: WINNING EDGE PRESENTATIONS HANDICAP - 1000 Metres

PATENTED (L. Neindorf) - shifted out on jumping away and momentarily inconvenienced **DAILY SPIRIT**. Rider reported the colt never really travelled during the event and when asked for an effort was flat footed. Laid out over the concluding stages. A post-race veterinary examination revealed the colt to be lame in the near hind leg. Trainer Mr A. Freedman was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial, approval to race jump out or race.

ALL BANTER (J. Toeroek) - inclined to lay in from near the 100 metres.

DAILY SPIRIT (T. Voorham) - inconvenienced at the start.

DIAMONDS (D. Tourneur) - slow to begin and raced very greenly throughout the event.

VIRTUE (NZ) (K. Crowther) - rider reported the horse was very disappointing and felt it may be shin sore. Laid out in the straight. A post-race veterinary examination revealed no visible abnormalities.

GHETTO (B. Vorster) - very awkward to begin, shifted in and became awkward on the heels of **ALL BANTER** and as a consequence was slow to begin. Got its head up and raced ungenerously for several strides near the 900 metres. A post-race veterinary examination revealed no visible abnormalities.

RACE 5: PIKE & JOYCE HANDICAP - 1300 Metres

LOMBARDO (J. Holder) - raced keenly in the early stages.

WICKED WHITT (P. Gatt) - awkward to begin, shifted out and contacted the hindquarters of **CELINE**.

CELINE (T. Pannell) - had its hindquarters contacted at the start. A post-race veterinary examination revealed no visible abnormalities.

RACE 6: BAROSSA FINE FOODS HANDICAP - 1300 Metres

The start of this event was delayed approximately five minutes.

IN HEART'S WAKE (C. Jones) - lost it's near fore plate en route to the barriers and was re-plated at the barriers. Underwent a pre-race veterinary examination and was passed fit to race. In the vicinity of the 400 metres was awkwardly placed on the heels of **FRANCISCA** for several strides as that horse had commenced to weaken. Held up for clear running from in the vicinity of the 400 metres until near the 150 metres. A post-race veterinary examination revealed no visible abnormalities.

EXALTED LAURETTA (T. Pannell) - Trainer Mr G. Young advised Stewards prior to the event of a change in tactics, that being that he would instruct his rider to attempt to obtain a forward position in running. Laid out under pressure in the straight. Rider explained as a consequence of this mare being slightly slow to begin and having regard for the formation of the field in the early stages of the event and being conscious to not be trapped wide without cover in the early stages, he was obliged to settle back with cover rather than attempt to obtain a forward position as intended.

GRINZINGER EXPRESS (NZ) (D. Tourneur) - raced wide without cover throughout the event.

MABEL JOSEPHINE (S. Logan) - was unable to obtain a more forward position in running owing to being trapped wide early and the early pace in the event.

FRANCISCA (J. Toeroek) - rider explained that when asked for an effort the mare was disappointing, weakened and did not finish the event off. A post-race veterinary examination revealed no visible abnormalities.

RACE 6: BAROSSA FINE FOODS HANDICAP - 1300 Metres (Cont'd)

DOMESDAY MAGIC (P. Gatt) - began awkwardly.

GLORY GAME (J. Holder) - began awkwardly. Raced keenly in the early and middle stages of the event.

AUSTIN RAIDER (A. Jordsjo) - awkward to begin.

RACE 7: CAUDO VINYARD HANDICAP - 1550 Metres

MONGOLIAN MARSHAL (NZ) - declared a late scratching at 2.15 pm by order of Stewards acting on veterinary advice that after arrival on course the gelding upon examination was found to be lame in its near hind leg. Trainer Mr S Gower was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial, approval to race jump out or race.

FLOP (B. Vorster) - approaching the 1000 metres was brushed and taken a little wider by **DOUBLE POCKETS**, which shifted out after being restrained. Raced wide without cover in the middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

OPEN MINDED (NZ) (L. Neindorf) - awkward to begin and shifted out at the start. Inclined to lay out in the straight.

DOUBLE POCKETS (J. Potter) - over-raced in the early and middle stages of the event. Approaching the 1000 metres when awkwardly placed on the heels of runners and after being restrained, shifted out, raced ungenerously and brushed with **FLOP** taking that horse a little wider. A post-race veterinary examination revealed no visible abnormalities.

RACE 8: TERRY HOWE PRINTING HANDICAP - 1250 Metres

PARK BENCH (NZ) (E. Finnegan) - awkward to begin.

BEEOKAY (J. Holder) - near the 1100 metres was unable to maintain its position when being inconvenienced by **MISS BELISA** as that horse was taken in. Held up for clear running from near the entrance to the straight until in the vicinity of the 150 metres and laid in form near the 200 metres.

EQUUS D'ORO (C. Jones) - inconvenienced over the concluding stages by **ROYALTY**, which shifted out to improve and as a consequence was unable to be fully tested for a number of strides prior to the finish.

I'M A LEGEND (S. Logan) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.

VACANT BLOCK (A. Jordsjo) - near the 1000 metres rolled out momentarily and inconvenienced **ISSARA**, which was taken a little wider.

JUST KAPPY (J. Potter) - laid out in the straight.

ROYALTY (B. Vorster) - rider reported the gelding laid in, in the straight. Over the concluding stages, when improving its position between **JUST KAPPY** and **EQUUS D'ORO** shifted out for a number of strides and inconvenienced **EQUUS D'ORO**, which was taken wider. Rider was reprimanded and advised to take greater care when shifting ground in future.

AUSSIE JACK (T. Pannell) - lost its near hind plate during the event.

RACE 8: TERRY HOWE PRINTING HANDICAP - 1250 Metres (Cont'd)

ISSARA (R. Hurdle) - near the 1100 metres shifted in and away from ROYALTY onto VACANT BLOCK, which shifted in and away onto MISS BELISA, which was inconvenienced for several strides. As a consequence MISS BELISA shifted in onto BEEOKAY, which was unable to maintain its position. Near the 1000 metres over-raced for a short distance after being taken wider by VACANT BLOCK, which rolled out. A post-race veterinary examination revealed no visible abnormalities.

BULLET KID (S. Fawke) - had its tongue-tie adjusted on arrival at the barriers.

MISS BELISA (P. Gatt) - inconvenienced for several strides near the 1100 metres.

RACE 9: TAB HANDICAP - 1400 Metres

BY THE POUND - declared a late scratching at 4.22 pm by order of Stewards acting on advice from the starter that the gelding refused to load. Trainer Ms K. Mooney advised the gelding would be required to perform to the Stewards satisfaction and load without delay in two Approval to Race jump outs prior to accepting for a future race.

TERRITORY TITAN (T. Voorham) - raced keenly in the early stages of the event. Held up for clear running from near the entrance to the straight for a short distance. Thereafter was disappointed for clear running for the remainder of the event and was untested to the finish.

GREAT BUY (L. Neindorf) - lost its near fore plate during the event.

ALSVIOR (P. Gatt) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

JAAMINT (S. Logan) - held up for clear running from near the entrance to the straight until inside the 300 metres.

STAN THE CADDY (K. Crowther) - Mr L. Weekley acting on behalf of Trainer Mr W. Clarken advised Stewards prior to the event that they would instruct their rider to attempt to obtain a more forward position in running from its wide barrier. A post-race veterinary examination revealed no visible abnormalities.

MOVANDI (D. Caboche) - approaching the 200 metres shifted in tightened and hampered HE WILL BOOM, which had to be steadied. Rider reprimanded and advised to take more care when shifting ground in future. A post-race veterinary examination revealed no visible abnormalities.

CLASSY JOE (J. Maund) - near the entrance to the straight shifted out to improve and contacted ANGASTON, which was taken out onto MISS MOSH, which was momentarily inconvenienced when taken wider.

ANGASTON (K. Zechner) - awkward to begin. Contacted near the entrance to the straight by CLASSY JOE, which shifted out in an attempt to improve.

FOUR OF A KIND (C. Jones) - Mr T. Stokes acting on behalf of Trainer Mr P. Stokes advised Stewards prior to the event of a change of tactics, that being that they would instruct their rider to attempt to obtain a position forward of mid-field. Near the 1300 metres became awkwardly placed on the heels of ANGASTON for a number of strides and thereafter was unable to obtain clear running form near the entrance to the straight until inside the 300 metres.

MISS MOSH (J. Potter) - approaching the entrance to the straight was inconvenienced and taken wider when contacted by ANGASTON, which was taken out by CLASSY JOE.

HE WILL BOOM (J. Toeroek) - awkward to begin. Approaching the 200 metres was obliged to be steadied when tightened by MOVANDI, which shifted in and was unable to improve its position for a short distance. A post-race veterinary examination revealed no visible abnormalities.
